## **Judgment (Merits) of European Court of Human Rights, March ...**

The European Court of Human Rights is the only international court with jurisdiction to deal with cases brought by individuals rather than states. In early 2010, the court had a backlog of over 120,000 cases and a multi-year waiting list. About one out of every twenty cases submitted to the court is considered admissible.

Forming a key part of international law, 177 cases have been entered onto the General List for consideration before the court. The jurisdiction of the ICJ is limited. Only states have standing to bring a compulsory claim against another state, and then only with the consent of the responding state.
